GYO-UN Membership Agreement

Your registration of GYO-UN Membership constitutes your agreement to follow and be bound by the following GYO-UN Membership Agreement.

Article 1 Definitions

This GYO-UN Membership Agreement (hereinafter referred to as "Agreement") provides the conditions applied between the GYO-UN Members (hereinafter referred to as "Members") who purchase the products and/or use the services for Members (hereinafter referred to as "Services") which AMS CORPORATION, LTD. (hereinafter referred to as "AMS") offers in the GYO-UN website run by AMS (hereinafter referred to as "Site") and/or in the emails which AMS distributes (hereinafter referred to as "Emails") and AMS.

Article 2 Modification

AMS reserves the right to update or modify the Agreement at any time without prior notice. All updates and/or modifications shall be deemed effective when the modified Agreement is shown in the Site and Members shall be pursuant to the modified Agreement.

Article 3 Compliance

Members shall comply with this Agreement to buy the products and/or get or use the Services.

Article 4 Definitions of Members

1. Members shall be individuals who sign up for GYO-UN Members with the prescribed registration form after acceptance of the Agreement and who are approved by AMS.
2. Members shall show the membership number invested by AMS to get or use the Services when Members use this Site.

Article 5 Registration

1. The registration of GYO-UN Membership shall be done with the prescribed registration form by the person who signs up for GYO-UN Membership in person.
2. The registrants shall give the true and correct information about themselves for the registration of GYO-UN Membership.

3. AMS may not approve the registration in case AMS concludes that the approval for Members is inappropriate. In addition, in case AMS concludes that the Member is appropriate after the approval, AMS may withdraw the approval. In case AMS do not approve the registration, or in case AMS withdraw the approval, AMS do not disclose the reasons.
4. AMS invests the membership number when the registration procedure is finished. Members shall not have plural membership numbers.
5. Members shall use and administer their own membership numbers on their own responsibilities.
6. In case Members find the robbery and/or unauthorized use by third parties of membership numbers, Members shall notify AMS immediately and follow the instructions of AMS.

Article 6 GYO-UN Membership Card

1. The membership card which AMS issues for Members to purchase the products and/or get or use the Services is designated as GYO-UN Membership Card (hereinafter referred to as “Cards.”)
2. Members shall not lend or transfer Cards to the third parties including the family because Cards are loaned to and used by the Members themselves only. AMS may confirm the Members’ identity when Members purchase the products and/or use the Services in the Site.
3. The term of validity of Cards is indefinite.
4. Members shall use and administer Cards on their own responsibilities.
5. In case Members find the loss or the robbery of Cards, Members shall notify AMS immediately. In case AMS suffers the damage without the notification of the loss or the robbery of Cards from Members, the concerned Member shall compensate AMS for the damage. In case Members loss the Cards or have had the Cards stolen, the new Card are issued and the membership number is also changed at once.

Article. 7 Registered Information

1. AMS shall handle all the information about Members which AMS acquires by the registration of Members, the use of the Services and other conduct in compliance with Privacy Policy which AMS provides.
2. In case the modifications of the personal information such as the name or the address occur, Members shall notify AMS by emails immediately.

Article 8 Emails Distribution

1. In case Members accept the Emails distribution, AMS offers the Services

which Emails including newsletters, questionnaires and advertisements from AMS are distributed to Members. Members may request to stop the Emails distribution by sending e-mails to AMS at any time.

2. AMS shall send Emails which AMS concludes them to be necessary for the administration of the Services regardless of the requests of Members.
3. AMS shall stop the Emails distribution to the registered email address in case Members request to stop the distribution.

Article 9 Prohibited Acts

When Members purchase the products and/or use the Services, Members shall not:

- Divert and/or appropriate the information which Members get from the Site and/or Emails for profit.
- Disturb the other Members and/or the third parties such as invasions of privacy and/or estate of others.
- Register in GYO-UN Membership using the email addresses which are obtained or generated illegally.
- Transfer or lend all the right of Members to the third parties.
- Send and/or insert any harmful computer programs and the like.
- Do any conduct against public policy.
- Violate any other laws or do any conduct which is possible to violate any other laws.
- Violate this Agreement and do any conduct which AMS concludes to be irrelevant.

Members shall indemnify any losses incurred in case Members cause the third parties and/or AMS any losses by the prohibited acts including, but not limited to the above.

Article 10 Damages

AMS may demand the damages to the concerned Members in case Members cause AMS any losses by purchase of the products and/or using the Services.

Article 11 Disclaimer

1. AMS may stop or suspend the Services without prior notice to or acceptance from Members when:
 - a. The fault of the system occurs.
 - b. AMS cannot offer any Services due to fire, blackout and the like.
 - c. AMS cannot offer any Services due to Act of God.
 - d. AMS concludes the stop or the suspension of any Services to be

necessary due to any other reasons.

AMS is not responsible or liable to any Members or entity whatever any loss or any disadvantage caused by the above.

2. AMS reserves the right to correct any errors or omissions in any portion of the Services AMS offers, to change, modify, remove, or terminate any portion hereof without any acceptance from Members. AMS is not responsible or liable to any Members or entity whatever any loss or any disadvantage caused by the above.
3. AMS is not responsible or liable to any dispute between Members or between Members and the third parties caused by the use of the information which is offered from the Site and/or the Emails, the use of the Services, and/or the purchase of the products.
4. AMS does not guarantee that the Emails and/or the newsletters which are sent from the Site, the server or the domain and the like do not contain the harmful information such as all kind of computer viruses.
5. AMS assumes no responsibility with respect to accuracy, timeliness, safety, usefulness, reliability and completeness of the information which Members obtain from the Site and/or the Emails.
6. AMS is not responsible or liable to any damages caused by the use of the information which Members obtain from the Site and/or the Emails.
7. AMS concludes that the purchase of the products and/or the use of the Services are practiced by the Members themselves when AMS confirms that the membership numbers which Members input or inform to purchase the products and/or to use the Services accord with the registered membership numbers by the prescribed method. AMS is not responsible or liable to any damages even if the above use is practiced by the third parties due to crib, unauthorized use or any other reasons.
8. AMS is not responsible or liable to any damages caused by that Members do not correct and/or modify the registered information, such as that any notice from AMS does not reach Members due to the negligence of correction and/or modification.

Article 12 Suspension and Termination of Membership

1. AMS reserves the right to suspend the use of the Services or terminate the membership without prior notice when AMS concludes that:
 - a. The Member executes any conducts against any laws or this Agreement.

b. The Member executes the unauthorized conducts regarding the use of the Services or the prohibited acts provided in Article 9.

c. AMS concludes to be appropriate due to any reasons.

AMS is not responsible or liable to any damages caused by the above.

2. AMS reserves the right to suspend the Emails distribution and terminate the membership when the distributed Emails return to AMS as error emails due to the negligence of correction or modification of the registered email addresses or the setting of block emails and the like.

3. AMS reserves the right to terminate the membership when AMS find the shipments such as Cards and the products are blind due to falsehood and/or the negligence of correction or modification of the registered addresses.

Article 13 Withdrawal
